Dear Residents/Businesses,

**RE: Shernhall Street – Road resurfacing**

I am writing to let you know that the section of Shernhall Street between Oliver Road and Barclay Road will be resurfaced from Monday 19 December 2016 and should take **three nights** to complete (weather permitting). The resurfacing works will take place overnight between the hours of **8pm and 5am**, Monday to Wednesday.

During the works there will be some temporary road changes as follows:

- Shernhall Street will be closed to all vehicles between Oliver Road and Raglan Road. There will be no vehicle access to this section of Shernhall Street from the side roads except for emergency vehicles but pedestrians will still be able to walk along the street as normal.
- Parking will be also suspended on Shernhall Street between Oliver Road and Barclay Road.
- Elm Road will be two-way for traffic between Eastern Road and Western Road to minimise disruption for drivers.
- Maynard Road will be two-way for traffic between Shernhall Street and Barclay Road to minimise disruption for drivers.
- Maynard Road will be closed at its junction with Shernhall Street, and access will be via Lea Bridge Road and Elm Road.
- Raglan Road will be closed at its junctions with Shernhall Street and access will be via Forest Road and Oliver Road.
- Barclay Road will be closed at its junction with Shernhall Street, and access will be via Lea Bridge Road and Elm Road.

Advance warning signs and diversion signs to let drivers know about these temporary changes will be placed in the area to help prevent congestion. Once the work is finished, all of the roads will go back to normal.

Please be advised there will be some machinery noise during the resurfacing work but our contractor will avoid using this machinery after 11pm wherever possible, to minimise the level of disruption to residents. Whilst we appreciate that this is an inconvenience, we hope that you will bear with us so we can return the roads to normal as soon as possible.

To keep the works on track and to return things to normal as soon as possible, we are asking local residents and businesses to avoid parking in the area until the work has finished. "No parking" signs and cones will be placed in the area, and if necessary, penalty notices will be issued, as a last resort vehicles may be removed and impounded if they are parked in a space that obstructs works. You can find contact details for the Council's parking enforcement contractors and details of their charges overleaf, should you need them. Parking will still be available in the adjacent roads during the works, so please use these
