Dear Resident / Business owner,

RE: Forest Road E17 road resurfacing work – Temporary road closures and parking restrictions

I am writing to let you know that road resurfacing work will take place on Forest Road between King Edward Road and Wellington Road from **Monday 17 July**. The work is due to last for 3 days and should be completed by Thursday 20 July, weather permitting.

This work is part of ongoing changes on Forest Road, and aims to improve road safety and access for walking and cycling. We sent you a letter last year explaining the results from the public consultation held in March 2016, and when the works would start. To help us carry out the resurfacing work safely, the roads in the following table will be closed temporarily at their junction with Forest Road between 9am and 5pm, with alternative access for vehicles being provided as shown.

Temporary road closure at junction with Forest Road	Alternative access for vehicles
King Edward Road	Queen Elizabeth Road
Century Road	Queen Elizabeth Road
Chatham Road	Rennes Road
Hervey Park Road	Walpole Road

To allow us to carry out the road works safely and on time, please avoid parking in the area. Look out for signs and cones to avoid parking in the wrong place as illegally parked vehicles will get penalty notices and may be removed - see reverse for details. Parking will be available on the side roads, so please use this space instead.

Please bear with us while we make these improvements to the area. Our contractors will be working to keep disruption to an absolute minimum and we will post regular construction updates online at www.enjoywalthamforest.co.uk/work-in-your-area/forest-road/construction.
