## **FOREST ROAD E17 – ROAD RESURFACING TEMPORARY ROAD CLOSURE AND PARKING RESTRICTIONS**

I am writing to let you know that road resurfacing work will take place on Forest Road between Blackhorse Lane and Pembar Avenue starting on **Monday 13 February**.

Each day, in order to carry out the resurfacing in a safe and efficient manner, a temporary closure of Forest Road between 9.00am and 4.00pm will be made at the junction with Blackhorse Road. This closure will affect eastbound traffic only, westbound traffic will be maintained on Forest Road past the working area down to the Blackhorse Road junction.

To allow us to carry out the road works safely and on time, we are asking local residents and businesses to avoid parking in the area until the work has finished. Look out for signs and cones in the area to avoid parking in the wrong place - penalty notices will be issued to illegally parked vehicles and they may be removed. See reverse for details.

The work taking place on Forest Road aims to improve access for walking and cycling, road safety and the look and feel of the area. We sent you a letter last year explaining the results from the public consultation held in March 2016, and when the works would start. Please bear with us so we can make these improvements to the area as soon as possible.
